This equipment is located on HG 22 (#1 section), and is used to power a scoop battery charger.

Citation #4900300 is issued citing 30 CFR Part 75.518 and citation #4900291 is issued citing 30 CFR Part 75.605 for conditions found upon investigation of this electrical equipment.

This equipment is located in an area affected by a mine explosion on 04.05.2010.

The Operator has a large history of similar citations/Orders following the mine explosion, reflecting the lack of care of the Operator to maintain
