27. Description of Accident (include equipment involved, the exact location in the mine, and status of rescue and recovery operations):

On Tuesday, February 6, 2018, at approximately 3:30 a.m., a miner, working as a mechanic was found between a coal rib and the continuous-mining machine. Part of a rib roll measuring 36 to 42-inches long, 28 inches high, and up to 14 inches, thick was found on top of the victim. The victim was transported to the Broadus Hospital where he was pronounced dead.

The information provided in this notice is based on preliminary data ONLY and does not represent final determinations regarding the nature of the incident or conclusions regarding the cause of the accident.
