



**Part I – ENTRY REQUIREMENTS**  
**2018 Mine Health and Safety Training Materials**  
**Competition** Training Resources Applied to Mining (TRAM) Seminar  
**October 9-11, 2018**

Deadline for Receipt of Entries: Friday, August 3, 2018

*LATE/INCOMPLETE ENTRIES MAY BE DISQUALIFIED. SUBMITTED ENTRIES ARE NOT RETURNED.*

**PLEASE NOTE**

Your entry must include a copy in electronic format (CD/DVD/flash drive). This will enable TRAM attendees to view your entry on a computer set up specifically for this purpose during the Seminar.

Awards will be presented to the competition winners during the TRAM Opening Ceremony.

The winning entry in each category will be copied to discs and distributed to all TRAM attendees following the presentation on awards.

**I. WHO CAN ENTER?**

The competition is open to all sources of mining-related training materials.

**II. WHAT TYPES OF MATERIAL ARE ELIGIBLE?**

Original health and safety training materials that you have developed or majorly revised since the 2017 TRAM Seminar are eligible. Entries cannot include the use of copyrighted materials, and you must be willing to share your entry with the mining community. Materials should address pertinent training requirements outlined in Title 30 of the Code of Federal Regulations (30 CFR) Parts 1-199, including Part 75 – Subpart P – Mine Emergencies.

**III. PROCEDURES**

A. Select **one** of the following competition categories\* per entry.)

1. Video (Ex.: Video, Video with Sound, etc.)
2. Printed Material (Ex.: Safety Talk, PowerPoint, etc.)
3. Mixed Media (Ex.: Video with Printed Material, Simulator, etc.)

**IV. *Material that does not clearly fit into Category #1 or #2 will be placed in Category #3.***

B. Each entrant **must do/provide** the following:

1. Package and submit your entry to safely arrive at the National Mine Health and Safety Academy by the submittal deadline of **Friday, August 3, 2018.** (See #VII for mailing address.) **Be sure to include an electronic copy of your materials (CD/DVD/flash drive).**

**We reserve the right to disqualify late and/or incomplete entries.**

2. You may submit multiple entries in one or more categories.

3. **A completed Entry Submittal Document (Part II, attached) must accompany each entry.** Be sure to include a copy of your materials in electronic format. *NOTE: Do not expect the Judging Team to assume any of the information requested in Part II.*

#### IV. HOW WILL ENTRIES BE EVALUATED?

- A. A team of judges will assemble to evaluate each entry.
- B. The judges will perform a critical evaluation of **two crucial elements required of each entry:**

1. **Element #1: Part II - Entry Submittal Document**

- Is the required Entry Submittal Document complete?
- Does the information provided “fit” the training materials submitted?

2. **Element #2: The Training Material**

a. From a **Trainer’s perspective** (i.e., someone utilizing the material)

- Is the training material user-friendly?
- Is it legible/easily understood?
- Is the material well-organized?
- Are all elements of the material readily accessible?
- Is the content current?
- Is the material technically accurate?
- Is the material relevant to the stated objective?
- Is the material relevant to the stated target audience(s)?
- As a trainer, would I use this material?
- Would I recommend this material to other trainers?

b-1. From a **Trainee’s perspective** (i.e., individual receiving the training)

- Are the images/handouts clear, legible, and easily understood?
- Is the sound (if used) clear and easily understood?
- Are animations (if used) relevant and easily understood?
- Will what I’m experiencing in this training session make me a safer/better-prepared miner/worker?
- Will this training result in a safer, work environment for me and my co-workers?
- Does this material make me more aware of the hazards associated with my job, and appropriate hazard controls?
- Would I recommend this training to my co-workers/friends?
- Did this training trigger a behavior-altering response from me?

b-2. From the **Operator’s perspective** (i.e., group receiving **Emergency Response Training**)

- Are the images/handouts clear, legible, and easily understood?
- Is the sound (if used) clear and easily understood?
- Are animations (if used) relevant and easily understood?
- Will what is presented in this training session better prepare my mine to respond to a mine emergency?
- Does the training material address all of the emergency response training elements found in Part 75 – Subpart P – Mine Emergencies?

- Will this training help to improve the competence and confidence level of all my mine management personnel who may be required to respond to a mine emergency?
- Does this training adequately highlight the serious and deadly nature of a mine emergency so as to positively impact the safety culture at my mine operation?
- Would I recommend this training to other operators?

#### **V. WHAT BECOMES OF MY SUBMITTED TRAINING MATERIALS?**

I understand that training materials submitted for the 2018 Mine Health and Safety Training Materials Competition will not be returned. The Mine Safety and Health Administration (MSHA) has my permission to use, duplicate, and/or distribute these submitted materials. Competition entries will be on display in the Academy Library throughout the TRAM Seminar.

#### **VI. WHAT HAPPENS IF I WIN?**

Winners of the Training Materials Competition are determined by the judges' evaluation prior to the beginning of the TRAM Seminar. All winners will be announced and presented with awards during the Opening Ceremony on Tuesday, October 09, 2018. Each participant will receive a Certificate of Appreciation. The winners in each category will also receive a plaque. A Grand Prize plaque will be presented to the contestant whose entry is judged to be the best overall. Wall plaques at the National Mine Health and Safety Academy are updated annually with name plates of the winners in each category. Also, a list of the winners will appear in the Holmes Safety Bulletin.
